Langebaan Country Estate(LCE) would like to inform that Egyptian Geese on the golf course will be hunted by using PCP Airguns with a .22 calibre that does not require a firearm licence.

Period of hunting will be during November 2022 and up to 15 December 2022

Cape Nature informed that we are allowed to hunt and the following conditions apply:

- 1.Hunting without a permit limited to 10 geese per day per hunter.
2. Hunting is only permitted from sunrise to sunset (No night shooting) Hunter to be in possession of hunting permits and firearm licences where required at all times.

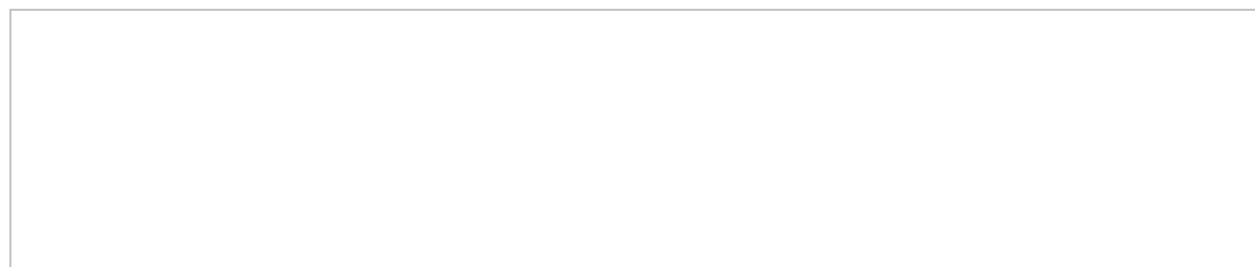
