 No people at home. I saw 1X brown & white Terrier X loose on the property.
 The Dog is in acceptable condition.

 I left a warning to provide dog with shelter. Will re-check.
 Assign Inspector Thu 29-Jul-21 Re-Check Jameson October
 I saw that the owner has complied to the warning and has provided the dog with adequate shelter. Water also observed and the dog is loose on the property. Body condition is acceptable.
 Will do a re-check when in the area.
 Assign Inspector Mon 30-Aug-21 Re-Check Jameson October
 The Terrier X is lying on the stoop.
 Water and shelter is provided.
 Body condition of the dog is acceptable.
 Will re-check.
 Assign Inspector Mon 27-Sep-21 Re-Check Jameson October
