Comments: Assign Inspector Thu 28-Oct-21 Warnings-Issued Patrick Chiwawa
 There was no people at this address.
 The dog is on a short chain and does not have a collar.
 The body condition of the dog is fair and acceptable.
 The chain is about 2m long.
 I issued a warning and will recheck.

Assign Inspector Fri 05-Nov-21 Warnings-Issued Patrick Chiwawa
 The owner did not adhere to my warning again as the situation remian the same.
 No water, the dog is still on a short chain without a collar.
 The dogs body condition is fair and acceptable.
 I issued another warning and will recheck.

Assign Inspector Fri 12-Nov-21 Re-Check Stephanie Fortuin
 Re-check. The dog was roaming free in the yard. The dog is in a fair condition. Water and shelter available for the dog. Will re-check.

Assign Inspector Tue 11-Jan-22 Warnings-Issued Patrick Chiwawa
 The dog is on a chain of about 2 metres long with out a collar. It looks like the dog has puppies by the look on the titties. The dogs body condition is fair and acceptable. Water and shelter observed. I issued a warning and I gave the warning to auntie Dellie of house number 4 Kapok street. I will re-check in 7 days.

Assign Inspector Tue 18-Jan-22 Warnings-Issued Patrick Chiwawa
 There was no people at this address but the owner did not adhere to the warning which I issued. The dog is still on a short chain without a collar. I observed water and a dog kennel. I also observed a small puppy which came out of the dog kennel. The body condition of both dogs is fair and acceptable. I issued another warning and I gave it to Hanse who stay at 2640 New Houses. I will re-check in 7 days.

Assign Inspector Tue 25-Jan-22 Re-Check Patrick Chiwawa
 There was no people and the dog was loose inside the property. Water, food and shelter observed. I also observed 5 puppies. The body condition of all the dogs is fair and acceptable. I will re-check when in the area.

Assign Inspector Mon 14-Feb-22 Re-Check Patrick Chiwawa
 The dog is still loose inside the property and Warren told me that 2 of the puppies were stolen. The body condition of all the dogs I observed is fair and acceptable. Water, food and shelter observed. I will do another re-check when in the area.

Assign Inspector Mon 21-Feb-22 Re-Check Patrick Chiwawa
 There was no people and I observed the female dog lying inside the property. There was another young white terrier x dog also inside the property together with the two puppies. The body condition of all the dogs observed is fair and acceptable. I will do another re-check when in the area.

Assign Inspector Mon 14-Mar-22 Re-Check Patrick Chiwawa
 Water and shelter observed. I observed one dog in a dog kennel but the dog did not come out of the dog kennel. I could not observe the body condition as the dog refused to come out. I will do a re-check when in the area.

 There was no people at this property but I observed two dogs lying inside the property and the one is on a runner. Water, shelter and a collar observed. The body condition of both dogs is fair and acceptable. I will re-check again when in the area.
