General Report Comments: After some searching for the house I eventually found the house. The house number is 584 Cambridge street. There was this lady that lives directly opposite this house who told me that the dog and 2 puppies are at the back of the house. She stated that the owners does not care for the dog and that she goes and make sure that dog has water and food. She stated that the dog not have milk for her puppies and that 5 puppies had died already and that there were only two left. She insisted that I take the dogs away from these people.

I then told her that i cannot just take dogs without consent of the owner or a court order. I told her also that if the dog was in the street, and being a nuisance to the neighbors, then I could take it. She then told me to accompany her to the back to where the dogs were and told me not to worry because she knows the owners very closely. She opened the gate and I followed. I found 1 female black and white dog, free roaming in the back yard. The dog came running to her playfully and I would see that there was a connection between her and the dog. She then informed me that she actually gave this dog to these people when it was a puppy. She showed me the kennel and I saw 2 puppies inside. The puppies were crying non stop. The dog then ran out into the street. To a neighbors yard and went to eat their dog's food. I then took the dog in as a stray and took the puppies for safekeeping as it would be cruel to leave the puppies. They were still very young and their eyes were still closed.

I then left a warning stating that the dog was admitted as a stray dog and the puppies for safekeeping. I also stated that the owner has 24 hours to contact the SPCA with this regard. I then took the dogs to Swartland SPCA
