Thank you so much for looking into this. We have a similar problem in Malmesbury court and I will forward you a separate email in this regard if that is in order with you.

Please refer to the attached, the details of the cases. The prosecutor is Mr Van Zyl.

The message that is being sent out to the community is that there are no repercussions for abusing an animal and people are getting away with animal abuse and breaking the law. So the terrible cycle just continues.

It seems that the trend now is to just deny ownership and then it gets thrown out of court. After ownership was admitted to the SPCA and admission forms signed. And also section 2(1)(q) and (r) are then completely ignored.

I really hope we can find some solution to this and again appreciate you looking into this matter.

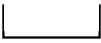
