- ☐ 1. To provide the animal/s with adequate food on a daily basis.
- ☐ 2. To provide the animal/s with sufficient potable water 24 hours a day.
- ☒ 3. To provide the animal/s with adequate shelter against the elements within 7 hours / days.
- ☒ 4. To provide the sick or injured animal/s with adequate veterinary treatment within 7 hours and provide the SPCA with a veterinarian report within the given time frame.
- ☒ 5. To clean and hygienically maintain the animal/s living environment within 7 hours.
- ☐ 6. To groom the animal/s within \_\_\_\_\_ hours and keep them in a fit and healthy state at all times.
- ☐ 7. To untie/unchain the animal/s immediately to roam freely inside the property or to place the animal/s on a "running chain" within \_\_\_\_\_ hours / days. (Advice can be obtained from Inspector)
- ☐ 8. Possible abandonment of animal/s on the property is suspected.
- ☐ 9. Tail / ear maiming or any other surgical mutilation is not permitted on animals.
- ☐ 10. Baiting, inciting or provoking any animal to attack another animal or to allow any animal to attack another animal is not permitted.
- ☒ 11. To contact SPCA Inspector C. BODENSTEIN on 082 416 7153 within \_\_\_\_\_ hours / days to discuss the concerns.

- ③ Your animals have no adequate protection or shelter against the weather elements. Provide them with such.
- ④ Horse is underweight, and likely has an underlying medical concern. Provide veterinary treatment.
- ⑤ The animal's living area is dirty and full of rubble. This must be cleaned.
- ④ Your dogs are underweight and likely has underlying medical conditions. Provide veterinary treatment.
- Compliance expected within 7 days.
- Animals can also be surrendered to the SPCA.

This warning has been issued in terms of the Society for the Prevention of Cruelty to Animals Act No 169 of 1993.

Failure to comply with this warning may render you liable for prosecution under the Animals Protection Act No 71 of 1962 and / or Performing Animals Protection Act No 24 of 1935.

Any person who:- obstructs, hinders or resists an officer authorised in terms of the Animals Protection Act No 71 of 1962 or conceals any animal shall be guilty of an offence in terms of Section 8(4) of the aforementioned Act.
