Mr Musk started to laugh and asked me to come inside, he then took me to a fridge in the kitchen and took out a bag of frozen chicken breaststroke and told me that his dogs does not eat pellets and that he cooks them chicken and rice everyday. Mr Musk also took me to the garden to show me where the dogs water is available. Errol then told me if he hasn't been feeding or giving water to his dogs they would have been dead by now. Mr Musk then wanted to know who the complainant is but I told him that the complainant is anonymous. From my observations the dogs are being taken care of. No welfare issues was observed. As I was leaving the property a neighbor across the street approached me and told me that he is glad the Spca is here because the dogs constantly barks and the owner does not take the dogs for a walk. I told the neighbor that he must call Law enforcement about the barking and that there is nothing I could do but educate the owner to walk his dogs. Nfa until further notice.
