Kesha appears to be more active today however she was limping when I arrived, I touched her right paw and leg and could not observe an apparent reason for the limp, she also stopped limping after my examination.

I advised Gladys that I will come back later today, in the hopes of finding Athini.

I also tried to call Athini, twice, but he did not answer my calls.
