I proceeded to issue a final warning (W5208) instructing the owner to take Kesha for veterinary treatment, if not done already and provide me with proof before Monday (19 Feb 2024 @ 09h00).

As I wnet back into the property to attach the warning to the main door Athini came from one of the bedrooms inside the house.

I was immediatly furious, as it is obvious the people on this property is taking the SPCA for weasels and covering for eachother.

I asked Athini if the dog was taken to a veterinarian , he said no. I asked him where was he this morning and he said at his friends place. I responded by saying you can visit your friend but not care for Kesha, he then said he went to try and borrow money for Kesha to be taken for treatment. In the same breath he said Kesha wont die if she waits till he gets money.

I gave him the final warning and said he has till monday. If there is no compliance I will obtain a court order and confiscate Kesha. I also gave him the option to surrender Kesha, however he did not want to.

I then left the property.

It is evident that the people on this property cant speak the truth as everyone has lied since this morning.
