An unidentified male then approached me and advised that the dogs were taken to Village Vet last week, he said he accompanied Athini. I asked for proof and he advised that he does not have it with him, and that Athini is not here.

I will go to Village Vet and enquire from them directly, if they have no proof I will obtain a court order.
