General Report Comments: Upon arrival, I was met and granted access to the property by a lady who identified herself as Adrian Crow. The daughter of the owner, who was currently at work. Adrian declared her age as 19, making her old enough to accompany on my inspection.

I introduced myself and shared the nature of complaint. Adrian advised that she is scared of the dogs and wont be able to take me directly to the dogs. I asked if i could observe the dogs through a window from inside the house and she agreed. Adrian then took me through the house and into the lounge area where i had a full view of the dogs.

I observed 5x dogs (the sixth dog is apparently an escape artist and has likely escaped the property). The area where the dogs are kept is an L-shape next to and forming the back section of the property (refer to google maps screen shot attached). The area is sufficient, and allows the dogs with sufficient roaming space. The dogs were all calm, laying in relaxed manners, making it clear that they dont have steriotypical behavior due to their space. The one dog, named Misa, is extremely aggressive and was trying to attack me the entire time through the window, while the other dogs were not bothered about my presence.

Adrian advised that they are looking for homes for 3x dogs, i advised het to discuss with her parents to surrender the dogs to the SPCA and that I would be able to load them when I come for my follow up inspection. She will relay my message.

Concerns observed:
There are 2x medium size kennels on the one side of the property which does not provide the dogs with adequete protection against the weather elements. This was relayed in a warning that was issued (W5203).
The content of the warning was explained to Adrian , who also signed and accpeted the warning on behalf of her father.
I also stated on the warning that they can call me to discuss the surrender process.

I did not observe any other APA contraventions during the time of my inspection .

Follow up is due in 7 days, if they would like to surrender, I will arrange for the trailer to come and collect the dogs.

Feedback to the Compl will be provided tomorrow morning then I will schedule the case for next week Wednesday, for the follow up regarding shelter.
