General Report Comments: Upon arrival I was met by Mr. Uat Birro who is the owner of the property. Mr. Birro was on his way out,before I stopped. I told Mr. Birro that I was in the area and would like to do a welfare check on the dogs. Mr. Birro granted me access to the property. In the front of the property the 2x dogs Jock a pitbull x male and Gucci a terrier x male are still loose and roaming freely. Both dogs body conditions is acceptable. On the the stoep the dogs have shelter,food and water. I asked Mr. Birro where the female Boerboel x,Stacey is and we went to the back of the property where I observed Stacey at the back of the property behind a locked gate. Mr. Birro told me that when Stacey is with Jock and Gucci they start to fight over the female,that's why he is keeping Stacey at the back of the property. Stacey also has shelter,food and water available and are also loose and roaming freely at the back. I asked Mr. Birro if he has considered to sterilize Stacey and he told me that he has not given it much thought but will contact me if he decides to get Stacey sterilized. The initial complaint was that the dogs are being locked up in small enclosures without food and water which was not the case because,Stacey was kept in a big enclosure because she went into heat and Mr. Birro did not want the 2x males to get to her because he does not want puppies. The complainant then said that the owner is hitting the dogs,this is the second time I have been to this property and I can clearly say that Mr. Birro is not hitting his dogs,because the dogs show no fear towards Mr. Birro when he approaches them,a dog that is scared of its owner will approach his owner with caution or will run away as I have seen over the years,but not these dogs. During my inspection I did not observe and welfare concerns. No further action until further notice.
