General Report Comments: Accompanied by Insp van Zyl and Law Enforcement Officers .

Upon arrival, we were met and granted access to the property by the owner. The owner was in a very frustrated and irritated state and it was clear that he was not happy with our presence.

The 2x horses were seen tethered next to the road at the main entrance, according to the owner he has done this now on purpose for the people to see and keep on complaining. The horses are placed there to graze as there are sufficient grazing available , and 2x large 25L buckets with water is placed next to them. He moves the horses to the house during rhe evenings where there are large trees.

The 1x dog is underweight and does not look good. According to the owner, the dog was born this was, he was the runt of the litter, and has never picked up weight.

I advised the owner that his animals might have underlying medical conditions and that he must have them assessed by a veterinarian f9r possible treatment to be administered.

I proceeded to issue a warning (W5212) stating:
1. The 2x horses and 1x dog is underweight and likely has underlying medical conditions.
2. These animals must be assessed by a veterinarian for possible treatment and proif of such must be provided on my follow up inspection.
I also provided the local veterinarians details for the owner.

The owner was granted 9 days to comply.
