Upon arrival, I was met and granted access to the property by the owner, Jade de Klerk.

The puppies were laying outside the property and the adult dog was confined to a short static chain, 3m, inside the property.

The adult dog has suspected mange. I also saw 1x puppy with a suspected broken leg. The other puppies appeared to be in good condition.

The property was dirty with plastic laying all over.

I convinced the owner to surrender the 1x puppy with a suspected broken leg.

I proceeded to issue a warning (W5235) stating:

1. Provide Blackie with veterinary treatment as Blackie appears to have mange;
2. To either have Blackie roam free inside the property or to place Blackie on a running chain (leaflet provided for guidance).

7 days were give to comply.

I further advises the owner to think about surrendering the bulk of the puppies, as it will be hard to care for them all as they grow up. The owner will think about this and let me know on my follow up.
