She then told me she has never been to this property it is her Aunt and Uncle that has seen it and they want nothing to do with the case. I told them that all our complaints are anonymous but she still refused to give their contact details. I told her that I need to know more and that I cannot go on the property without permission. I asked her if she can phone the uncle and aunt to allow me to look from their property into the backyard of the property in question but she said they were not at home. I left a warning for the owner to contact me within 48 hours.
