General Report Comments: Upon arrival, I was met and granted access to the property by Michelle. Lexi was laying at the front door, when she stood up I saw that she was limping with her hind leg pulled up, not putting any pressure on her left hind leg. Michelle advised that they suspect she was knocked by a car. A lady from a welfare organisation in Hopefield apparently came last night to look at the dog and gave the dog some pain meds and said they must monitor for 7 days, thereafter if not better they will take the dog to a veterinarian.

I physically examined the leg and it was evident that the leg was fractured. I also showed the owner, as above the hock I could see bone misplacement and severe swelling. The owner decided to surrender Lexi as she agreed Lexi was suffering unnecessarily and that she can't take Lexi now to a veterinarian.

Puppies: there are 5x puppies left, they are in very good condition. They have Food, water, shelter and a clean living environment. They are deciding if they are going to keep some, but they will definitely now keep 1x male. I advised that they sterilise him asap.

I will go past the property in 3 weeks to do a final check and try to have the owner sterilise the one male through us.
