General Report Comments: Upon arrival, the community was standing outside. One lady identified herself as Jennifer Simon, she works on the property. But the owner chains the dogs as they are extremely aggressive, she is petrified of the dogs.
Jennifer stated that not to long ago these dogs killed another dog on the property as well.

I could not see the dog that was attacked and was shown that the dog is laying at the back of the property. I went to the neighbors to look over the wall, this is where I saw a husky confined in a 3m x 3m cage. The attacked dog was laying lifeless in an open cage next to the husky.

I went around to the front gate again, and saw the one rottweiler that is kept on a 10m chain in front of the main house door appears to have an injury on his right eye, as there was also a lot of flies sitting on the eye.

I issued a warning (W4622) to have the dog taken for veterinary treatment.

Jennifer spoke with the owner earlier who advised her that she (Nadia) is in Cape Town and is trying to arrange transportation to get home asap. I gave the warning to Jennifer to give to the owner. I could not attach the warning to the gate as the dogs were trying to attack me through the gate, they would have ripped the warning to shreds.

While I was there another lady handed me her phone and said Nadia is on the line. I spoke with Nadia and informed her about the situation and the issued warning. She advised that her husband is working out of town and that he won't be able to assist and she is stranded in Cape Town, she is just waiting for transport then she will deal with the matter. I informed her that the dog must be taken for treatment and that we will follow up tomorrow.
