General Report Comments: PROACTIVE

While driving in the area, the owner approached me and advised me that his dog is sick and asked if I can have a look. He stated that the dog is defecating worms and is lethargic.

Upon arrival at the property, the dog was found laying under the boat. The dog appeared sick as the dog was underweight, walked slowly, had his head hanging low, old vomit was seen on the dog's front legs and the dog had droopy eyes. I did a physical check where I checked the gums, which were a normal colour, the eyelids were a normal colour, the dog was not dehydrated and did not have a temperature. The dog had no ticks or fleas present. I did not see the dog's faeces to verify the defecating of worms.

I advised the owner that the only assistance I can offer is to humanely euthanise the dog, alternatively he can take the dog to his nearest veterinarian for examination and treatment. The owner did not want to have the dog euthanised and advised he will take the dog for veterinary examination. He stated that he will contact Margi from CARE as she assisted him previously.

I issued a warning stating:
The dog must be taken for veterinary assessment as the dog appears to be sick.

There are no other animals on the property.
