General Report Comments: Upon arrival, I observed 2 dogs free roaming inside the property. A gentleman approached me from inside the house and introduced himself as Mr. WITBOOI, the owner.

Witbooi advised that he only chains the 1 dog when he is at work, as the dog escapes underneath the precast slab on the left side of the property. The dog apparently digs holes and the dog goes and fight with the neighbors dog. I advised Witbooi that he will have to fix the hole, cement it or whatever else that will work, but the dog cant be chained. He understood and said he will make adjustments to the fence.

The yard has been cleaned, and I only observed fresh recent feaces. The dogs had access to 2 water bowls.

I am not satisfied with the carport as shelter, and the owner advised that he has 2 large kennels at the back of the property that he would like to move to the front, but the kennels are to heavy for him to manage. I asked he I can arrange people to come and assist and he said he will greatly appreciate the assistance. He has friends coming over the weekend and if they dont manage to move the kennels he will message me so we can come and assist him on monday, the 8th. He also indicated to me that by the front door there is additional coverage for the dog, which I saw and will allow as temporary shelter.

The dogs are in good condition with no veterinary or health concerns observed.

The chain has been removed from the post completely.

I will follow up next week monday.
