I showed her a picture I took of how I attached the warning. She then said I must wait a few minutes and went across the street into house nr 7.

She came back with the sleeve with the warning inside and asked if it is this. I said yes. She then went back to Nr 7 and shouted and swore at a young boy. She then came back to me and advised that she has problems with this young boy that removes things from her property and keeps it with him and he does not tell her about it.
