General Report Comments: Accompanied SBM LE Officers to conduct a welfare inspection as the owner applied to have more than 2 dogs on his property.

Upon our arrival, the owner's son approached us from inside the house and advised that the owner, his father is currently at work but that he will grant us access to conduct an inspection.

There are 3x adult dogs free roaming on the property. The yard is a "U" shape with a partition in the middle separating the back yard when needed - this door was open on our arrival. In the back yard I observed 3x large wooden kennels which provides adequate protection against the weather elements. There was 3x 5L water water buckets with water inside available for the dogs. The living area was clean and no veterinary or health concerns were observed regarding the dogs.

I observed a chain laying on the ground and asked about the purpose of the chain, I was advised that the younger male dog gets chained during feeding times as he is food aggressive and a bully towards the other dogs, and since they apparently begun to chain him during feeding times he has calmed down.

In my opinion the property is large enough to accommodate the 3 dogs.

No contraventions in terms of the APA was observed during our inspection.
