General Report Comments: Upon arrival, no one appeared to be present as there was no response to my presence.

The warning I left yesterday was still fixed to the gate, as I left it.

I obtained the owner's contact details and called her.

She advised that the horse is a rescue horse that she got in a pregnant state last year. After the horse gave birth the horse struggled to gain weight. The horse has been at this property since April 2024. She comes 1-2 a week to the horse and brings additional food for the horse during her visits.

The veterinarian from St Helena Bay Veterinary Clinic attended to the horse last week where the horse was assessed, microchipped, inoculated, dewormed and passport issued.

The horse is currently not being ridden as she has to gain more weight. She has a guy that works with the horse weekly, who will be at the premises from 11h30 tomorrow. The owner will also be present then. Arrangements were made to meet in person tomorrow and discuss the way forward.

The owner demanded to know who the complainant is and made a suggestion that it is probably the person who wants to rent the piece of land she is currently renting as they are in a dispute. I stated to her that I am not at liberty to disclose the complainant's details and she advised that she has her ways and will find out herself.
