I saw the dogs is tethered to his kennel and has 270 degree movement space, the rope is approximately 5m long attached to the dogs material collar with a swivel. The dog has sufficient roaming space, but it will be much better if the dog can be on the runner.

Muriel advised that the dog keeps ripping the runners pin out of the ground, and they cant afford cement to cement the pens. They did cement the pins initially, but the pens were to short and the dog ripped them out as well.

I advised that they place the cable around the washing line poles, as the cable is the same lenght. Muriel understood and said she will inform her husband, as they are currently considering giving the dog to her cousin as they feel they are not giving him the space he requires. Muriel advised that she and her husband will decide to either move the cable or give the dog away.

I will come by next week to see what they have done.
