It was also evident that the dogs ate the food as more fresh faeces was observed and the food was less than yesterday. The dogs all still had water and the area is still fairly clean, as the dog defecate at the end of the premises.

There are plenty crates with blankets available for the dogs. The dogs appeared to be in good condition with no veterinary or health concerns observed.

The owner still has time to provide more light at stable area, and provide suitable water bowls.

After I walked through the people tried to bombard me again with questions but I did not give any attention to it and greeted them and left.

I provided my manager with my findings and also shared the videos with her.
