General Report Comments: Upon my arrival, the owner of the dog was not present. I was met at the premises by the following individuals: Gunther, and an unidentified elderly woman.

I entered the premises as I have permission from Mr Cilliers to do so.

I took a video from entry, as I walked through and captured all my findings.

There was food available for all the dogs. There are large self feeders placed around with food inside. There were still of the other pellets with the cylinder shape and new pellets as well. Each of the self feeders were 3/4 full. There was also steel bowls with food placed inside placed around. I did observe some of the dogs earing during the time of my inspection.

There are multiple large water buckets placed all over, and they had water inside as well.

The area was fairly clean and I could see the owner cleaned recently, as he was at the premises around 23h00 last night. The stools are of a normal to a bit loose form, but are a good colour with no abnormalities observed.

The following dogs are kept in smaller areas.

The puppies:

1. the older batch are kept in an enclosed area where they cant escape from. The had 2x large water buckets, a blanket and a self feeder with food inside.
2. The youngest batch are kept in an enclosed area where they cant escape from, they have access to water and a blanket. They are still young and not eating pellets yet. The mother dog can jump in and out of the area as she wish and I saw her with the puppies this morning feeding them.

2x adult dogs are kept separately, the male is prone to fight with the younger males, hence he is kept separate. He has a large wooden crate inside the enclosed area in which he can lie. He had 2x large water bowls available and also has access to the pig water nipple. I saw the dog drinking water from the water nipple with no difficulty. There was an empty bowl in their area as well. Not sure what was placed inside.

The rest of the dogs have a large area to roam, where they are able to run around and jump the walls (low bearing) inside.

The stabled area has 3x dogs inside. This area is also big allowing the dogs to run around and jump up and down the walls(low bearing). These dogs are kept separate as the 2 are sterilized and the other one is rather aggressive and fights with the younger males.

These dogs had water, food and their living area only had fresh feaces. The one window cover has been slightly opened allowing the dogs more exposure to light, as well as the one sliding door.

The entire area has sufficient ventilation as air can easily move through . The area is cool and not once that I was there was the temperature concerning.

Since I was alone today, the dogs were much calmer and I was also able to check their teeth. Their teeth are in good condition, white with no plague, no broken, cracked or chipped teeth. The dogs coats were soft and shiny and no external parasites were observed. I also did not see any worms in the dogs stools.

The owner did comply with the warning issued.

Every inspection I have done after the initial inspection the dogs had access to water, a clean living area, adequate protection against the weather elements, and no veterinary or health concerns were observed.

During todays inspection no APA contraventions were observed

The owner advised that he will remove the dogs from the property over the weekend, as he can't deal with the community's interference any longer and he also decided no to buy the property anymore. He will inform me as to where he moves the dogs to.

I will conduct every morning for this week an inspection as well as monday morning to verify if he did indeed move the dogs.
