General Report Comments: Upon arrival, I was met and granted access to the property by the owner.

I observed the dog to still be on heat as her genital area was still very swollen.

I informed the owner that I managed to arrange for sterilization, and that they are willing to assist the owner for R250.

The dog is still not ready to be sterilized, as the operation would still be too risky.

I advised the owner that we can give it another 2 weeks, and the owner also mentioned that she will have the R250 ready in 2 weeks time, I must just call or whatsapp her ahead of time so that she can confirm if the dog is off heat and that she is at home.

I will just message Tracy from LAC and inform her about the R250 that the owner will be willing to give, as Tracy initially indicated that they will assist the owner for a minimum of R200. I mentioned R250 to the owner, so that LAC can at least get a bit more money to cover their costs. (I involved LAC, as I was informed that we can ask them if they are willing to assist with sterilization of animals in the Langebaan area. When I called Tracy to give her feedback on this case, I asked if they would be able to assist and Tracy advised that they will gladly but that their normal price is R850, but that she is willing to assist this owner for R200 and they will cover the rest of the costs. I advised Tracy that I will see if the owner will be willing to pay more and let her know when and how so that we can make arrangements for the dog to be booked in)

Regarding the other dogs on the property. No APA contraventions was observed regarding them.

I will however advise that we monitor the older male dog that is on a runner, he is at a age where he might begin to loose weight/muscle mass, and the owner might be hesitant to euthanize when the time comes.
