General Report Comments: I was successful in obtaining a warrant from the Vredenburg magistrate court to seize the dogs at 408 Better life, Ongegund, Vredenburg. I was accompanied by, Trainee Inspector Mathabela and Mr. Isaac from Vredenburg law enforcement. On arrival the daughter opened the door and told us that her mother is working. I issued her with the warrant and explained to her that the warrant gives me the powers to seize every animal that is in in a bad state on this property. I seized 8 x Adult dogs with severe mange and 5x 2week old puppies. I left the seizure notice with the daughter and went with dogs to Vredenburg animal hospital. Dr. Anel was on duty and did a assessment on the dogs. Dr. Anel suggested that the humane thing to do is to humanely euthanized the dogs. Attached are the admissions, seizure notice and warrant. Will discuss the case with my manager.
