**APPLICATION FOR THE ISSUE OF A WARRANT IN TERMS OF SECTION 8(1) OF  
THE ANIMALS PROTECTION ACT 71 OF 1962**

**SUPPORTING AFFIDAVIT**

I, Jameson October, hereby make oath and declare in English as follows:-

**1.**

I am an adult male employed as an Inspector by the Swartland and West Coast Society for the Prevention of Cruelty to Animals ("SPCA") at Plaas Eenzaamheid R45 with contact telephone number/s 022 289 0998 or 082 959 4879. My certificate of magisterial authority for this district is attached marked "A".

**2.**

The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.

**3.**

In terms of my duties as an officer of the SPCA and our objects, especially to prevent the ill-treatment of animals, I may, where necessary, exercise the powers in terms of Section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.

**4.**

On 30 September 2025, the West Coast SPCA received a complaint concerning a dog at 6 Vink Street, Langebaan, alleged to have a dental problem. On the same day, at approximately 10:30, I attended the property to conduct a welfare inspection. The owner, Mr. Mumya Ndudzathe, granted me access to the premises. On inspection, I observed one brown male terrier-type dog and one white and brown female Jack Russell cross named

Jojo. Mr. Ndudzathe attempted to lift Jojo and open her mouth to show me her teeth; however, the dog resisted and attempted to bite him. Mr. Ndudzathe explained that Jojo does not allow anyone to touch her mouth and that her teeth are yellow and appear to cause her pain. I informed Mr. Ndudzathe that the condition is likely painful and that Jojo requires veterinary attention. He agreed to make arrangements to take her to a veterinarian and said that 7 days is long enough for him to get Jojo to a vet and that he has a job. I issued him with a warning number W6994, granting seven (7) days to comply. Mr. Ndudzathe signed and accepted the warning, after which I departed from the property.

## **5.**

On 7 October 2025, I returned to the property at 6 Vink Street, Langebaan, to conduct a follow-up inspection. There was no one at home, and I did not observe the female Jack Russell cross, Jojo, on the premises. I spoke to neighbouring residents to obtain a contact number for Mr. Ndudzathe, and they provided me with 078 978 8320. I telephonically contacted Mr. Ndudzathe, who confirmed that he had not yet taken Jojo to a veterinarian, stating that he had not had time to do so. I reminded him that he had been given seven (7) days to comply and that he had previously confirmed this was sufficient time. I further explained that the dog is in pain and requires urgent veterinary treatment. Mr. Ndudzathe responded that he would take the dog when he has time.

## **6.**

On 9 October 2025, I again attended the property at 6 Vink Street, Langebaan. Mr. Ndudzathe was not at home; however, a young person present on the premises granted me access. The young person attempted to open Jojo's mouth, but she resisted and did not allow us to examine her mouth. It appeared that she was still in pain. The young person informed me that the owner was at work and that Jojo had not been taken to a veterinarian. I then left the property. I subsequently attempted to contact Mr. Ndudzathe telephonically, but he did not answer his phone.

## **7.**

I have reason to believe that one or more offences listed in Section 2 of the Animals Protection Act 71 of 1962 have been and are being committed for the following reasons:

### **7.1.**

The white and brown female Jack Russell cross named Jojo on the property is not receiving vet treatment. I am of the reasonable view that this is an offence in terms of Section

2(1)(a) and 2(1)(e) of the Animals Protection Act no 71 of 1962 and that this animal is suffering unnecessarily.

**8.**

I therefore request a warrant in terms of section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 (where appropriate) to examine the conditions in which the aforesaid animal is kept and if necessary remove the aforesaid animal to prevent further suffering.

**9.**

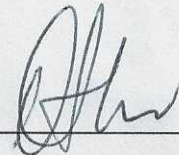
I request that such a warrant authorise members of Law Enforcement, the SAPS and Members of the Society for the Prevention of Cruelty to Animals (SPCA) to accompany me upon such examination.

**10.**

In addition, the SPCA requires to take photographic and / or video footage, and take into custody all / any evidence and / or equipment as may be reasonably necessary for the purpose of prosecution and, if necessary, may exercise its powers in terms of section 5(1) of the Animals Protection Act 71 of 1962.

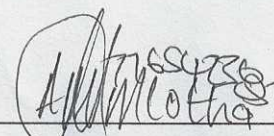
**11.**

The SPCA is governed by an Act of parliament, namely the Societies for the Prevention of Cruelty to Animals Act 169 of 1993. The SPCA's objectives in terms of this Act is to prevent the ill-treatment of animals by promoting their good treatment by man.

**WARRANT IN TERMS OF SECTION 8 (1) OF THE ANIMALS PROTECTION ACT 71 OF 1962, READ TOGETHER WITH REGULATION 468, ISSUED IN TERMS OF SECTION 10(1)(b) OF THE AFORESAID ACT**

To: **INSPECTOR OCTOBER OF THE SWARTLAND AND WEST COAST SOCIETY FOR THE PREVENTION OF CRUELTY TO ANIMALS (SPCA)**

**WHEREAS** it appears to me from information on oath that there are reasonable grounds to believe that one or more offences listed in Section 2 of the Animals Protection Act 71 of 1962 have and are being committed within the Magisterial District of **HOPEFIELD** at the premises **6 Vink Street Langebaan.**

This is therefore to authorise you to enter and search the identified premises and direct you to:

- examine the animal(s) and the conditions in which it is kept;
- take such photographic and / or video footage as may be reasonably necessary;
- take into custody all / any evidence and / or equipment required for the purposes of prosecution;
- if required take with you onto the property the following entities:
  - **MEMBERS OF THE SOUTH AFRICAN POLICE SERVICE (SAPS);**
  - **MEMBERS OF THE SOCIETY FOR THE PREVENTION OF CRUELTY TO ANIMALS (SPCA);**
  - **MEMBERS OF LAW ENFORCEMENT**
- seize such animal(s) and take it into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal(s);
- deal with it/them according to law/bring it/them before me to be dealt with according to law.
