General Report Comments: CATTLE
I observed 16 cows, 11 calves and 5 bulls. The cattle are not confined and Mr Van Schoor is too old and he seem not sure about the total number of the animals on the farm. The cattle graze on the open ground and in the bushes. I counted 32 cattle. All the cattle that I observed are in a fair and acceptable body condition. There is enough grazing on the farm and there is a dam and a stream that provides drinking water for the cattle.
SHEEP
The sheep are also out in the bushes and in the veld grazing. All the sheep observed are in a fair and acceptable body condition. They drink from the dam and the stream.
DONKEY
The jenny is over 20 years according to Mr Van Schoor. Previously I and inspector October tried to remove the donkey but we couldn't catch her as she is scared and doesn't allow people close to her. The jenny has a skin condition but I couldn't issue a warning as he told us to take the donkey but we couldn't.
DOG
The X- breed dog named Jessy is about 3 years old. She is not sterilized. Her body condition is fair and acceptable. She does have access to water and shelter.
I will go back to the farm to see if I can be able to catch the donkey
