General Report Comments: Inspection Summary:
I conducted door-to-door inspection in Riverlands with Inspector Van Zyl. During the inspection, we observed a property located on Landboustreet, Riverlands. The property was fully fenced, and the gates were closed, with no occupants present at the time of the visit.

Findings:
Boerboel Dog:

Tied at the back of the property without a collar. Lacked proper shelter. Appeared underweight. Chain was too short, restricting movement.

Pitbull Dog (Nearer to Gate):

Tied without a collar. Lacked proper shelter. Chain was too short, limiting mobility.

Unknown Dog (Presumed Pitbull):

Located under a roof, behind shade cloth. Could be heard barking but was not fully visible. Also tied, potentially in unsuitable conditions.

Small Black and White Puppy:

Moving freely on the property.

Action Taken:

A written warning (W4558) was issued to the owner, Mr. Martin Moses, with the following directives:

All dogs must have collars within seven (7) days.

The brown Boerboel must gain weight and be provided with adequate nutrition and must pick up weight within 7 days.

All dogs must have proper shelter that meets welfare standards.

The owner must contact us urgently for a full inspection of the premises and the condition of the animals.

Recommendations:

Follow-up inspection should be conducted after seven (7) days to ensure compliance with the issued warning.
