I asked Mr. Le Roux fir the key and he came to open the shed. I loaded both dogs into the Spca vechile and went back onto the property. The pigeons enclosure is dirty,water not potable and they did not have any food. At the back Mrs. Le Roux was keeping 3x tortoises in a small enclosure. I confiscated the 2x dogs,3x pigeons and 3x tortoises. Will follow up.
