General Report Comments: Upon arrival at 2 Koperfontein, the owner of the property was not present. I was met by the complainant, Mrs. Lourens, who informed me that the owner of the house and the dog in question works at a building directly opposite the house.

Engagement with the Dog Owner:
I proceeded to the workplace identified by Mrs. Lourens and found the owner, Mr. Thomas Faroa. He accompanied me back to his house.

Findings:
The dog in question was not present at the property. Mr. Faroa stated that the dog had been taken to Moreson Farm to stay with a friend.
The complainant reported that a child had attempted to pull the dog through the gate, causing it to cry loudly.
Mr. Faroa denied this, stating that the complaint was related to the dog's barking.
A ginger cat was present at the property and was found to be in an acceptable condition , with access to a litter tray, food, and water.

Follow-Up Actions:
I informed Mr. Louwrens of the situation. He confirmed that he knows the owner and stated that he would visit Moreson Farm to check on the dog and provide feedback if any concerns arise.

Conclusion:
At the time of the investigation, the dog was no longer present at 2 Koperfontein. No immediate concerns were noted regarding the welfare of the cat at the property. NFA UNTIL FURTHER NOTICE
