General Report Comments: Following the receipt of a complaint regarding Chocolate Angels in Kalbaskraal, I conducted an inspection on the same day.

Upon arrival, Mr. Jason Heyman granted full access to the property for a thorough inspection. The following observations were made:

There are 24 dogs on the property, all of which are sterilised.

All dogs are in good body condition, with no signs of mange, ticks, fleas, or malnutrition.

No veterinary concerns were identified.

Each dog has access to adequate shelter, clean water, and ample food supply.

Veterinary records were reviewed, and all dogs have up-to-date vaccinations.

No dogs were found to be tethered; all are free-roaming within the property.

There are no birds or cats on the premises. Mr. Heyman stated that he has not kept birds for over five years, and all bird cages on the property were empty.

Based on my findings, there are no violations of the Animal Protection Act (APA) observed on the property.

Additionally, Mr. Heyman recently organized a mass sterilisation drive in Kalbaskraal, funded through sponsorships. A total of 100 dogs and cats were sterilised during this initiative. The SPCA was aware of this effort, as one of the dogs under monitoring in the area was sterilised through this program.

Conclusion: No contraventions of the APA were noted. I spoke to the complainant today and provided her with feedback and she is very happy. NFA until further notice.
