General Report Comments: While doing inspections in Patrys Street some teenagers stopped our vehicle and told us to go look at the house of Peter. The children told us that the owners cannot look after themselves and that the dogs are in a very bad condition. They claimed that some of the dogs had mange and that there are a lot of puppies that looks sick. I asked what number does Peter live and they said I must just look down the road at the house that looks like a scrapyard. I went and saw a very dirty looking property and stopped. It was nr 6. I called out and a male person who introduced himself as Peter Smit came out. Another male named Rasta came out as well and was very aggressive. He told us to Voertsek from the property and that we will not take their fucking dogs. Another brother named Piet also came out and started swearing at us. Because they were getting more hostile I contacted Marvin Cloete from Swartland Law Enforcement to come and assist us but he did not pick up his phone. We then drove to the Law Enforcement offices in Moorreesburg and they gave us a number of another official Mr Adonis. Mr Adonis accompanied us to the property. When we got there Rasta was no longer there and only Piet and Peter was at the property. They gave us access to do an inspection. I asked Peter how many dogs are on the property. He said that there were 2 adult dogs male and female and 10 puppies. The male collie cross dog had mange, The female terrier cross dog was in the beginning statges of mange. Peter went to show me were the puppies were. The puppies were covered in fleas. No water available. There were makeshift shelter available but the living area was extremely dirty. The male dog was underweight. They could show me no food and said they do not have. I wrote them a warning nr 5273. Official Adonis talked to them and advised that they cannot keep this amount of animals on the property. They received a fine for the amount of animals on the property and the state of the property. I asked Peter if he can afford to take the dogs to a vet and to buy dog food and he said no and I gave him the option to sign over the dogs to the SPCA. Peter agreed to sign the dogs over to the SPCA.
