General Report Comments: Bully. The male Pitbul dog named Bully is on a static long chain of about 7m long with a collar around his neck. According to Mornay, Bully does not like other dogs except the two dogs on the same property namely Sky and Peanut. The walls on the property are about a metre high. Bully is sterilized. Bully's kennel is broken on one side and Mornay said that Bully is biting and breaking the kennel. Bully's body condition is fair and acceptable. He does have access to water. Sky. The female dog named Sky is loose inside the property. She is sterilized and her body condition is fair and acceptable. She does have access to portable clean drinking water and shelter. Peanut. The male juvenile Jack Russel X is also loose inside the property and his body condition is fair and acceptable. Peanut is not sterilized and Mornay informed me that he plans to have the dog neutered. Peanut has access to fresh drinking water and shelter. His body condition is fair and acceptable. The overall living environment is clean. I issued a Notice to comply and I will recheck. After I notified the complainant about my findings she informed me that she is going to get a dog kennel for Bully but she would like the SPCA to take the kennel to the property as she stays in the area and doesn't want the dog owner to know it's her who complained.
