General Report Comments: Accompanied by CN officials, Donnie Malherbe and Britney.

Upon our arrival, we were met and granted access by Mr Pniel. Mr Pniel was very agitated by the presence of the SPCA and made a lot of remarks and statements regarding past occurrences.

We advised that we are here to conduct a routine inspection, at first Mr Pniel was hesitant and requested proof of our warrant to be on his premises. Donnie from CN calmed him down and he allowed us to go to the back of the property where animals are kept. Mr Pniel advised that he got rid of a lot of his animals and only has a few left, this is apparently due to the SPCA, according to him.

Animals seen:

4x Leopard Tortoises

4x Angulate tortoises

2x Cape Grey Mongoose

The tortoises are free roaming in the back, it is a large section of the property. There is sufficient shelter, water pools and food sources available. The 2x mongoose are kept in a large enclosure catering for their basic needs. They have a lot of hiding space, and it was rather difficult to spot them. The animals observed appeared to be in good condition with no veterinary or health concerns.

No other wild animals were observed during the time of our inspection.

Mr. Pniel does not have a current PAPA licence, and his lapsed in 2020.

Mr Pniel and CN discussed permits and that CN will draw up the paperwork for the permits, CN also advised that they will put Mr Pniel in contact with Dr. Michael Swart from the StateVet to finalize his PAPA.

I did not observe any contraventions in terms of the APA during the time of our inspection.

I could not take pictures as Mr Pniel, did not grant me permission.
