General Report Comments: I arrived soon after the facility opened. I and inspector October went to meet the manager Irene Visser who granted us permission to do the inspection . Our Inspection was as follows

The birds enclosure

There is plus/minus 20 enclosures that houses different types of birds . All the birds are in enclosures which are in one big enclosure. Same type of birds are housed together. The enclosures are well maintained and there is no protruding wires that may injure the birds. All the birds are housed according to compatability. Birds of prey or predators can not gain access into the big enclosure. There is enrichments in the form of hiding species,hanging ropes and peches. There is bait stations around the big enclosure and there is fly traps too

Diet

Diet is species specific. Parrots are fed seed and fruit. The budgies are fed budgie seed. The birds are fed once every day and the public is not allowed to feed the animals. The leftover food is thrown away. All the birds have access to clean drinking water

Hygiene

The enclosures are cleaned twice a day early in the morning and later in the afternoon. The caretaker is in the enclosure all the time and he stays at the facility.

Rabbit and Guinea pigs.

The enclosures are well maintained and the quantity of the animals in the enclosures is acceptable for the number of the animals. The rabbits are fed sandy cubes and fresh vegetables. All the animals have access to clean drinking water. There is natural enrichments in the form of tunnels and boxes enabling the animals to hide.

Pigs

There is two pigs that are fully grown. The pigs use nipples for drinking water. They use oathay for bedding and they are fed sandy cubes .

Donkey,Alpacas,sheep and goat

These animals are always together out in the field at the back. They do have access to fresh drinking water and they do have shelter too. All the animals observed are in a fair and acceptable body condition.

Food storage

The food is stored in a feed room that is well kept and all the feed is stored in containers that are sealed. They are not marked but they are of different colors. The feed room is free of mice .
