General Report Comments: I saw 1x brown and white pitbull x female with 3x puppies,tan adult terrier x male and 1x black and tan German Shepherd x male. The pitbull x female,her puppies and the tan adult terrier x is loose on the property. The German Shepherd x male is on a 3m long chain with a collar. The German Shepherd x male don't have any shelter,as where the other dogs can go onto the stop where they can seek shelter from the weather elements. Water was also observed. There were no people at home. I managed to get the owner of the properties cellphone number and called him@0633637569. Mr. De Wet the owner told me that his fiance comes to feed the dogs every day . He also told me that the German Shepherd x male is chained because the neighbours had a problem with the dog always jumping into their property. Body conditions of the dogs is acceptable and they don't look like dogs that is being starved. I issued a warning W6985 to install a runner for the GSD x male and to also provide him with adequate shelter. Will follow up within 7x days.
