General Report Comments: I conducted a welfare inspection at Dogs and All, where I was granted full access to the premises by Mr. Smit, the owner.

Prior to beginning the inspection, I queried with Mr. Smit about the dogs allegedly kept at the Strawberry Farm in Paarl. He informed me that they have not had any animals at that location for the past year. It is recommended that Paarl SPCA confirm this information on site. I also questioned Mr. Smit regarding reports of flooding at the premises, which he denied. Based on my own observation, the kennels are positioned on a gradual slope, making it unlikely that flooding would occur.

Regarding the complaint about alleged reckless driving, Mr. Smit stated that he has not received any complaints in this regard, and no evidence was available to substantiate this claim.

At the time of my inspection, there were no emaciated dogs observed, and no German Shepherds in poor body condition were present on the premises.

Upon arrival at 08:15, cleaning of the kennels was nearly complete. The kennels were observed to be in acceptable condition, well maintained, and free from any hazards or structural damage that could cause injury to the animals. Each kennel had fresh, clean water and adequate shelter. Fly traps were placed in proximity to the kennels to assist with fly control.

The dogs have access to relief camps, where they are rotated during the day. There is a roster displayed, indicating the dogs' exercise and rotation schedule. The animals are also walked by students as part of their enrichment.

The feed room was clean and organized. Food was stored in sealed, rodent-proof containers, and there was sufficient feed available on site.

All dogs had individual records documenting their working schedules, veterinary treatments, vaccinations, and deworming, which were found to be up to date. The dogs are microchipped, and dipped once a week, as well as treated with Simparica for external parasite control.

During the inspection, one Boerboel named Juliana appeared lethargic. When questioned, Mr. Smit informed me that Juliana had been taken to Groenkloof Veterinary Clinic for treatment. He presented the veterinary treatment as proof. I subsequently contacted Groenkloof Vet, who confirmed that Juliana had indeed been examined and was under veterinary treatment.

In conclusion, the overall welfare standards at Dogs and All were found to be acceptable, with all basic animal welfare requirements being met at the time of inspection. Refer to the attached checklist for more detail.
