General Report Comments: There is three adult dogs on this property and the dog named Lexy have six puppies so in total there is nine dogs and one adult female cat and three kittens. All three adult dogs are covered in ticks. The dog named Lexy is very thin and she does have six puppies. I observed fresh drinking water and adequate shelter. All the dogs are running freely inside the property. Jolin informed me that he gave the dog named Suzie a tablet for ticks but he couldn't show me proof of his claim. Jolin also informed me that the people from Langebaan Animal Care were at his property and he claimed that they gave him a week to improve the welfare of the animals on his property. The body condition of all the cats is fair and acceptable. Jolin could not show me dog food when I queried the type of food that he is feeding the dogs. I issued a warning for the following APA contraventions:  
2(1)(b) unnecessarily starves or under feeds the dog named Lexy  
2(1)(e)allowing the three adult dogs to be infested by external parasites
