General Report Comments: On my arrival in Moorreesburg, a gentle men by the name of Mr Hugh Maroem came to me and complained about his neighbors in no.8 Protea street, that the neighbors are not looking after their dog(the dog is underweight and on a short chain). He then directed me to the house.

Upon my arrival to the house no.8 Protea street Moorreesburg, I was welcomed by Mrs Evelina Dorethea Mentor the owner of the property/premises according to her, she was with a family member lady who lives with her by the name of Leara Benson 38 years old.

I asked Mrs Eveline of they have a dog in the premises, she said yes and immediately took me to the back side of the house where the dog is kept, she then said the dog belongs to her grandmothers son(Mr George Benson a younger brother of Mrs Laera Benson), Mrs Evelina continued by saying that George brought the dog in her property without her permission somewhere in November 2025 she was not at home the time he brought in the dog, she only saw the dog when she came back from work and she couldn't confront George because he threatens and uses vulgarity words,  
In that situation, she had to contact SAPS, but SAPS could not do anything then she went to open a protection order against George.

Mrs Eveline said she can't look after the dog and does not want the dog in her property that is why she had to call the police from the best of her knowledge, but unfortunately the police did nothing as also the day police came to her property George was holding knives and one of the police member came out of the vehicle and picked up the knives handed back over to Mr George and the police departed living Mr George behind.

George is not living with Mrs Eveline according to her.

I educated Mrs Eveline that according to under Animals Protection Act no 71 of 1962(definition of "owner") she is now regarded as the owner of the dog since the dog is been living in her property with her longer than enough, therefore she will have to sign over the dog more especially she did mentioned that, she doesn't want the dog in her property.

She then signed over the dog and I brought it to the spca Darling.  
She also showed me a protection order that she opened against Mr George, I took photos of the documents of the protection order, refer attached.
