General Report Comments: On my arrival, I was welcomed by Mr Bibo Mangaliso care taker of the animals, Mr Mangaliso said he just recently started to be a care taker for the animals about 3 weeks ago, of which the owner of the animals Mr Yordy requested Mangaliso to look after his dogs while he is away on vacation with his family, Mr Mangaliso said he does not have contact details of the owner of the dogs.

I observed 2 male boerbols, black & brown and the other one is light brown, both not castrated and had short tails and they are kept separately in camps with wooden dog kennels with water available. Both dogs appeared physically looking good in condition with no veterinary problems or health concerns. The dogs are fed dog pellets bobtail brand and Butta brand dog pellets and sometimes cooked meat, according to Mr Mangaliso. Living environment was cleaned.

According to Mangaliso, the dogs get chance 1 at a time to roam around the yard when he cleans the camps and juring the night rotating every day.

I asked Mangaliso about the female boerbol with its puppies, he replied that the owner of the boerbol with its puppies came to fetch them as he does not know where he lives as he keeps relocating, Mangaliso gave me the contact details of the boerbol puppies owner Mr Kert 0640310299, I contacted the number Mr Kert on the 28/04/2026 13H06 (he answered my call, and I asked if could meet up with him to discuss the concerns of his animals the female boerbol with its puppies, he then replied by saying he lives in Durbanville and immediately he said I must a bit then he hang up the call.). I then contacted Mr Kert again 28/04/2026 19H25 he answered my call and I introduced myself to him and he replied by saying he knows it's about the dogs then he immediately hang up the call.

Mr Bibo Mangaliso allowed Mr Kert to keep his female dog with its puppies for a while because Mr Kert said to him he is still looking for a place to live at.
