General Report Comments: On arrival I met Nadier who informed me that the dogs belong to him and Farrier is his son and does not stay at this property. I observed two adult dogs and a puppy. The property is used as a recycling place. The two adult dogs are on chains.

Rufus: This is the adult male Pitbul x. He is on a running chain with a collar around his neck. His body condition is fair and acceptable. I observed fresh drinking water next to the steel drum. Rufus does not have adequate shelter as he is using a steel drum which can get hotter in hot days and can be very cold in winter.

Queen:

The female GSD black + brown dog named Queen is on a short static chsin with a collar around his neck. Queen's body condition is fair and acceptable. Queen is also using a steel drum which is not adequate. Queen's body condition is fair and acceptable. I observed fresh drinking water next to the steel drum.

Gans:

This is a pitbul puppy with deformed legs. The puppy was born like this and does not show any signs of pain. On arrival the puppy was inside his kennel. He was not tied to anything.

I issued a warning advising Mr Van Niel to:

(1)provide adequate shelter for the dogs named Rufus and Queen of which he argued claiming that he got the drums from CARE meaning it's allowed according to him.

(2)remove the dog named Queen from the short chain.
