General Report Comments: On our arrival in Kalbaskraal house no.196 tortelduif Street, with inspector October and field officer Mpho Baloyi (myself) accompanied by the Malmesbury law enforcement team Mr Abongile together with his other colleagues.

We met Mr Graeme Peek the owner of the animals in his property, we then went into his property, we observed the dog named Roxy was groomed but not groomed properly and Roxy had external parasites still(fleas).

The other dogs was still appearing physically underweight and had skin problem (possibly mange), the owner did not comply with the notice to comply that was issued on the other day of the first investigation(adequate food was not available and veterinary treatment was not rendered for the animals that had skin problem (possibly mange), the food was available in the form of white bread.

There was only 2 pitbull dogs that appeared physically looking good in condition with no veterinary problems or health concerns.

There was faeces and urine on the floor of some of the shelters room.

The owner said he is always away as he drives trucks and helping people.
Inspector October issued the owner with a warning, refer attached warning no.W 6352
