General Report Comments: I was granted access to the property by Mr. Fanie Van Zyl who is the owner of the animals. Mr. Van Zyl took me to back of the property where I observed 1x black and tan German Shepherd mix male called Legend, 1x black Scottish terrier called, Scottie and 1x Dorper sheep ram, called Koos. I explained to Mr. Van Zyl why I'm here and he showed me where the animals sleep. All the animals have access to the garage and caravan that's always open for shelter and at night, Legend and Scottie sleeps inside the braai room, where I observed water and food bowls and a mattress where the dogs sleep. Koos sleeps inside the garage at night. There were some sheep droppings but I could see that is fresh dropping. There is no indication that Mr. Van Zyl is not cleaning the animals living area. There is also a bird cage but Mr. Van Zyl told me that the 2x budgies he had flew away, someone forgot to close the door properly. I asked him if Legend has or had a ear infection and he said yes and showed me the treatment he got from Westland animal hospital. Mr. Van Zyl says the ear infection is much better than it was. No welfare concerns were observed. I will do a follow up to check on the ear condition.
