General Report Comments: On my arrival, I met Mrs Elizabeth Boysen, Mr Petros Feyster and Mrs Carmelia Booyesen, both living in different houses separately,

There was multiple 7 dogs freely roaming inside the farm of which some owners of the dogs they were not available, the 7 dogs appeared physically looking good in condition with no veterinary problems or health concerns.

According to the 3 farmers mentioned above, they said the dogs are barking sometimes during the day and night because there are some unknown public members crossing over the farm, and the dogs mostly are males of which if there is a female dog on heat then the male dogs fight.

Mr Petro Feyster surrendered his 2 female Africanis dogs, admission no. E3978 & E3917 and the dog was humanely euthanized at Darling SPCA.

Mrs Carmelia Booyesen requested to get her female dog to be sterilized, I then collected the dog and brought it to the spca Darling to be sterilized, admission no. E3986.

There was also a male pitbull dog brown/white that I observed at the other house of which Mr Petro said the dog belongs to Mr Daniel and he was not available but at work. The dog was on a static chain of 6 meters long not to the collar, no shelter, and the dog appeared physically looking underweight in condition. I then issued a notice to comply and gave it to Mr Petro to hand it over to my Daniel, see notice no. I005619.
