REPORT FINDINGS / COMMENTS:		
Upon arrival, I called out and an adult female came outside. I requested to speak with the owner of the dogs, and she went to the back of the property to call her. The owner then came out, and I introduced myself and explained the concerns. She informed me that she had an argument with her cousin brother and that they would be leaving the property the following day to move to Chatsworth. I observed four dogs. All were kept on short static chains with no access to drinking water and two did not have access to adequate shelter. I issued a warning instructing the owner to: 1. Provide sufficient potable water for the dogs at all times. 2. Provide adequate shelter within seven days. 3. Place the dogs on running chains within seven days. She provided the new address where the dogs will be taken: 127 Hopefield Road, Chatsworth. She signed and accepted the warning.
