On the property next to the Wendy house I observed 1x white pitbull male with brown spots on his ears on +-8 meter long static chain with a material collar. Shelter is provided in kennel form. Body score 4/5. Living area is clean and water is available. The dogs name is Jannie and he is 8 years old,sterilized when he was 6 months old. I also noticed that Jannie has a cancer growth on his side. Christiaan told me that they saw it recently but it keeps on growing. I advised Mr. Esua to get the dog to a vet. I can see that Jannie that Mr. Esua has been taking good care of Jannie,and could not have prevented the cancer. Mr. Esua asked me if I can give him until next week because the are only getting paid on the end of the month. I agreed because Jannie is not busy dying. I issued warning W6367. Will follow up.
