General Report Comments: On my arrival, I was welcomed by Mrs Denive Loubser known as one of the family members within the property, I observed a pitbul dog named Tracy roaming free, and other male pitbull adult dog on adequate static light leash+chain of about 9 meters long to a collar.
Shelter was available, water was available, living environment was cleaned (though the property environment on itself had stones allover the yard).
Tracy appeared physically slightly underweight of which Mrs Denive also said Tracy is fight the other dog that is on a leash, therefore they don't want the dog anymore.

The other dog on a static leash+chain appeared physically looking good in condition with no veterinary problems or health concerns.
There was another dog light brown boerbol ofwas kept on different side alone of which wasable to go in and outside the house, it looked physically good in condition with no veterinary problems or health concerns. It was very aggressive of which I couldn't get too closer to it avoiding to provoke it.
The complainant according to Mrs Lorraine spca receptionist, her employee contacted the office line that she wants the spca to come collect Tracy as she was attacking the other dog in the property probably a pitbull mentioned above. When Lorraine replied that they can bring Tracy to spca, thats when her employer the complainant change the statement that there are 2 dogs in this property without shelter, water and are on short chains.

I collected tracy and brought it to the spca Darling and was humanely euthanized, see admission no E3601. NFA.
