General Report Comments: On my arrival to the property where the cats live, I met Mrs Geouna Alexander elderly younger sister of the complainant, then immediately said she doesn't want to go up and down to SAPS and court about the matter of the cats, in question, I asked what happened to the cats and where are the cats as well as did she see the incident happening, she then replied by saying she didn't see that but she is suspicious that the guy their neighbor might have thrown boiled water over the cat as he did the same previously 2-3 months back to another small kitten. I asked why she didn't report the first incident, and she said they are afraid of him.

She then said the owner of the cats is the complainant Mrs Hentorika she is the one who launched the complain while at work.

I then issued a notice to comply and gave it to the younger sister Mrs Geouna to hand it over to Mrs Hentorika to provide adequate veterinary treatment for the adult cat.

Later on, when I arrived back at spca Darling, I got a message from Lorraine a receptionist of spca Darling that, Mrs Sharon contacted the spca office line that she wants me to call her back, I then phoned Mrs Sharon, she answered and asked me why I didn't do anything to the guy(suspect) who threw boiled water to the cats, I then replied her that unfortunately the lady Ms Geouna known as an elderly younger sister of the complainant, she said she didn't see the incident happening but she is assuming it might be the guy their neighbor, and she does not want to get involved or nor go to SAPS as a witness since she did not witness the incident happening with her eyes,

Mrs Sharon then said, she was also surprised after she dropped Mrs Hentorika at SAPS station to open a case of animal cruelty, and when she came back from taking the cat to the vet, she found Mrs Hentorika waiting outside saying that she can't open a case against the guy because she is scared of him.

Mrs Sharon, she then after, said she did went to the guy herself and had a chat with him. Mrs Sharon is a boss/employer of Mrs Hentorika a complainant.
